B.2 Brief summary of the topics addressed

International Conference

"New Challenges for Local Governance"

Date and place: April 12-13, 2012; Lisbon, Portugal

Very well attended conference (after review process there were more than 50 participants) addressed five main issues: the economic crisis and local government finance; local and regional government reforms; local public services provision; urban policies and sustainable development; and citizen e-participation. The most reflected and evaluated were various anti-crisis measures adopted by sub-state governments. More cases documented reverse processes to long-term prevailing decentralization. Similar specific features were revealed in public services delivery. There emerged cases when previously privatized or privately delivered services returned back under more direct supervision or provision by governments. More specific cases of public administration reforms were discussed, including powers redistribution, with special attention to meso-level of government. Presented papers also confirmed rising and more diversified application of e-participation in governance and planning.

32nd International Geographical Congress Cologne

Date and place: 26 – 30 August 2012, Cologne, Germany

Almost 30 contributions offered very good overview of existing diversity in topics concerning our Commission profile. Set of presentations dealt with theoretical and methodological issues, current research directions, with various supporting and partly overlapping conceptual frameworks. Positive feature had been more papers focusing on environmental governance. More traditional, but still important contributions analysed innovations in public sector. Besides current processes in public administration reforms, there were more extensively debated wider scale public sector and institutional reorganizations that had emerged in more countries. Set of papers addressed numerous experiences (good, as well as conflicting cases) with development oriented governance structures in regions, cities and rural communities. Presented papers covered issues in well developed states as well as in developing and quickly growing states. Important were papers addressing governance in various specific e.g. marginalised conditions and more specific communities (e.g. immigrants).

International Seminar

Finance in Transition / Financialization & Governance: Lessons for the Future Date and place: 15-17 May 2013, Bratislava, Slovakia

Contributions delivered during this seminar covered various spatial scales in relation to current financialization of various spheres social life. Among frequently mentioned and analysed issues were consequences of the financial crisis. Set of papers addressed financial sector and financial services and their development, including spatial differentiation in serving business and citizens. Another group of papers discussed financial flows of various kinds, their instability, impact on investments. Financial issues substantially influenced situation of regional and local governments. In more cases

relations between local-government, financial institutions, investment finance and links to other actors were analysed. The seminar finished with inspiring round table discussion with numerous ideas and comments concerning future research of various financial linkages across public and private sector; local, regional and central state; as well as links to global financial situation and financial networks operating through the world.

C08.13 Geography of Governance Commission session - "**Traditions and innovations in governance - better meet the needs of people**"
Date: 4-9 August 2013

Already during preparation of our sessions' framework, we were strongly influenced by general framework of the regional conference. We were focusing on search for suitable intersections of "old and new" in government and governance. Discussed were interesting governance issues concerning planning and development programming related to various social and economic activities. As an important issue we can consider governance in large cities, ports, or cities facing large development initiatives. More authors discussed issues related to traditional governments, old territorial structures as well as new innovations and induced adaptations. In global scale, we could observe rising attention paid to participatory structures in governance at the local and neighbourhood levels. We could observe more similarities, but as well some differences in application of such approaches in governance in various parts of the world.

C. Networking

Networking activities during 2012-2013 focused on sustaining longer term developed links to other scientific disciplines and their bodies. It includes especially International Political Science Association and its members focusing on local government issues. They regularly participate on our events.

As a new experience, we organised 2013 meeting in Bratislava in co-operation with Regional Studies Association, its Research Network on Geographies of Finance (and Post-Socialist Transformations). This group of scholars, sometimes quite narrow, now expanded into over 100 members dealing with geography and financialization all over the world.

Second form of networking had been repeated effort to strengthen Commission activities by means of COST project supporting co-operation and networking thanks to EU funds. Despite positive evaluation of our project proposal, due to tight competition, our project had not been successful.
