COMB was co-organizer of the following Conferences / Workshops:

- IGU Thematic Conference on the "Transformation of Traditional Cultural Landscapes", Koper, Slovenia, 24–26 September 2019.
 The Conference was organized by the following IGU Commissions: Land Use and Land Cover Change, Biogeography and Biodiversity, Local and Regional Development, Mediterranean Basin and Land Degradation and Desertification. The Conference had attracted about 70 participants, 60 oral presentations and 6 poster contributions.
- 2020 2. 20th International Conference on Computational Science and its Applications (ICCSA) Cagliari, July 1-4
 Organized by Chiara Garau (DICAAR, University of Cagliari), <u>Anastasia Stratigea (COMB Chair National Technical University of Athens)</u>, Paola Zamperlin (University of Pisa) and Francesco Scorza (University of Basilicata)

The session attracted 25 participants and 10 oral presentations of papers. Papers presented were also published in O. Gervasi, B. Murgante, S. Misra, Ch. Garau, et al. 3. 4th Euro-Mediterranean Conference on "VISIONING MED 2020+ / Mediterranean in Transition: Preserving the Past - Preparing for the Future" (http://www.smartbluecity.com/) – Athens, October 9-10 Organized by the National Technical University of Athens and the Smart City Mediterranean Cluster, in cooperation with, among others, IGU Commission Mediterranean Basin.
The Conference has attracted 120 participants and 74 paper presentations. A

number of publications (Special Issues and Edited Volumes) are under preparation stage.

b. A brief summary of the topics addressed at each meeting and the findings or conclusions resulting from the discussions if appropriate.

- 2019 1. The focus of the Conference was on the study of the linkages between landscape features, their fair perception and valorisation on the one hand and their relevance for the design of policies related to land use and regional development, such as agricultural policies, regional policies and spatial planning policies.
- 2020 2. At the core of discussion in this workshop were laid developmental issues of island regions, mainly regarded as lagging-behind due to insularity repercussions. Territorial cohesion issues were raised as well as competitive advantages of such regions to be used for featuring sustainable future development pathways.
- 3. At the heart of the conference were laid themes related to smart, resilient and sustainable pathways, data management and smart urban development, cultural resource management, etc. of Mediterranean regions. Also the Conference organized special sessions for the presentation of the EU 'Green Deal' strategy and the 'Climate-neutral and Smart Cities' initiative; and an expert panel workshop on "Visualizing the MED beyond 2020: Downscaling the Green Deal and the Climate-neutral and Smart City Strategic Mainstreams", elaborating on the barriers applying to the implementation of the above EU future orientations in the Mediterranean Region.
