C20.25 Islands: Time for Global Island Research(ers) (TGIR)*

DESCRIPTION OF THE SESSION

The Session we propose for the IGU Centennial Congress 2022 'Time for Geographers' aims to put the spotlight on local island researchers of various (inter-)disciplinary backgrounds, and their work towards achieving island sustainability. Especially early career researchers from small islands across the world will be welcome to present and exchange their sustainability challenges, perceived knowledge gaps, and the solutions they have come to find.

In global assessments, some SIDS (Small Island Developing States) are still not included, and data from small islands is merely integrated. Similarly, in the conventional international peer-reviewed publication system of science, local islanders rarely appear as co-authors or first authors. An independent research profile is a necessity to keep science independent and to be able to tap into international funding schemes (e.g. for marine conservation projects). A transdisciplinary research landscape needs to be established for and by local students and scholars. This enables them to start planning for locally determined sustainability targets and aspects, and to contribute globally with valuable lessons for our 'planet of islands'. Session contributors will present their research themes empirically anchored in local contexts.

This paper session provides opportunities to engage with ideas of sustainability within

island geographical scholarship, the challenges of island sustainability beyond the academy, and the shifting field of global-local island research itself. We welcome papers addressing concerns such as (but not limited to): What is the role of island researchers in taking matters forward to achieve specific Sustainable Development Goals? What are the forces at play in processes of social and economic polarization, environmental degradation, and the generation of 'uncommon futures' in island societies? What alternative agendas and concepts might island geographic research advance for the future? How can international visibility and the voices of young islanders and SIDS scholars be enhanced, to contribute to global discussions of visions for home islands?

The two main objectives and outcomes will be a) to provide an interactive platform to international research to connect "from island to island" in a way they would normally not have the scope, time and capacity, and b) joint peer-reviewed publications by the contributors on the challenges and barriers found and the solutions that can facilitate local research towards meaningful local science that enables sustainable use and development of island resources (both human and natural). This will be supported by a small exhibition of island research and work during the congress, which would also bring islanders together "across all seas" in a hybrid face-to-face/digital manner.

At this stage, it is too early to list names and affiliations of some expected speakers, but possible themes are: (1) *Islands in Anthropocene*; (2) *Island decolonization and indigeneity*; (3) *Local artists + art scholars presenting at the conference - visual attention*; (4) *Link between terrestrial and marine ecosystems and related extractive industries*; (5) *What does it mean to be "models of the world" in everyday debates?* (6) *UNESCO SIDS participation & case studies*; (7) *The social-ecological roles of reef passages*; (8) *Indigenous Fisheries Knowledge – lost stories or integrated modern management?* (9) More topics to be announced.

C. Networking

The Commission on Islands (C20.25) has been active for over a decade now, having been approved by the IGU Executive Committee at the IGU Brisbane Conference in July 2006. Since its inaugural conference was held in Taipei, Taiwan in 2007, the Commission has gathered scholars from around the world who are

interested in studying islands as distinct geographical phenomena and in exploring their significance in the contexts issues concerning global change, sustainability and resilience research, cultural geography and humanities, political and economic geography, and other key aspects of development. The Commission also works together with relevant national and international organizations in promoting research on and awareness of island development issues, as well as to strengthen the significance of the wealth of diversity of island cultures

The IGU Commission on Islands has consistently networked and collaborated with other island studies organizations, most prominently the International Small Islands Studies Association (ISISA), Island Dynamics, Future Earth- Coast, A Sea of Connections-Contextualizing Fisheries in the South Pacific Region (SOCPacific) Project, and so on. It has furthermore collaborated with other IGU Commissions, most notably previous C12.21 Indigenous Knowledges and Peoples' Rights. The Commission plans to initiate dialogue with more Commissions to look into potential collaborations such as co-organizing conferences (e.g. staggering days at same venue, with overlapping research interests convening together at the end of one conference and beginning of the other; or, convening together throughout, but with some keynotes and sessions in plenum). These might include Commissions such as C20.06 Coastal Systems; C20.12 Geographical Education; C20.17 Geography of Tourism, Leisure, and Global Change; C20.21 Global Understanding; C20.22 Hazard and Risk; or C20.32 Marginalization, Globalization, and Regional and Local Responses.
