### 2. Corresponding Members

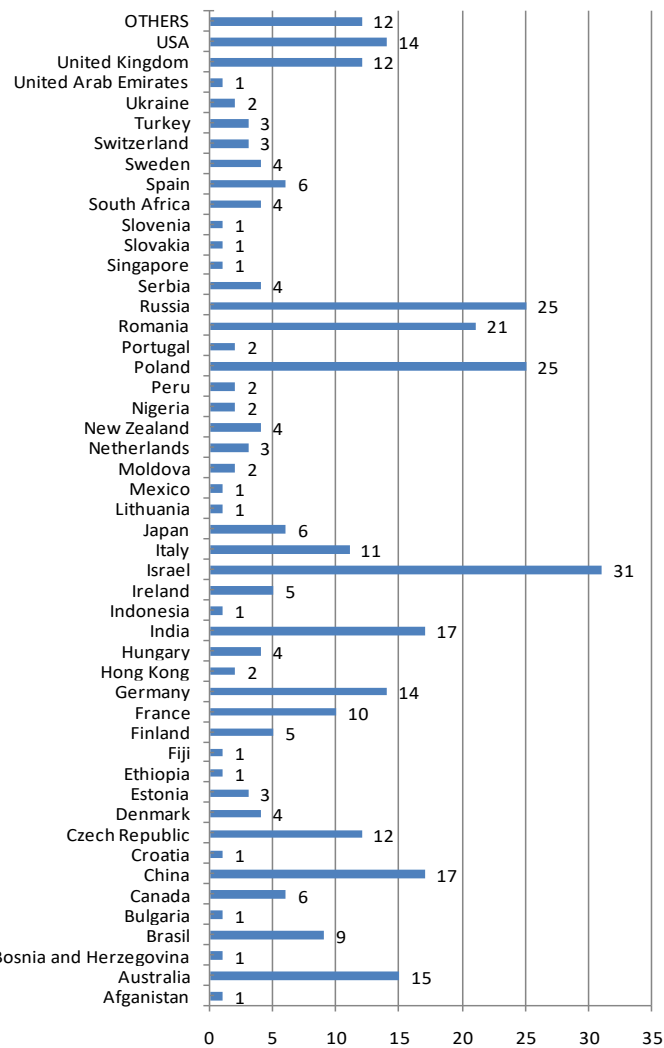


Figure 1. Number of Corresponding Members by country, 2022

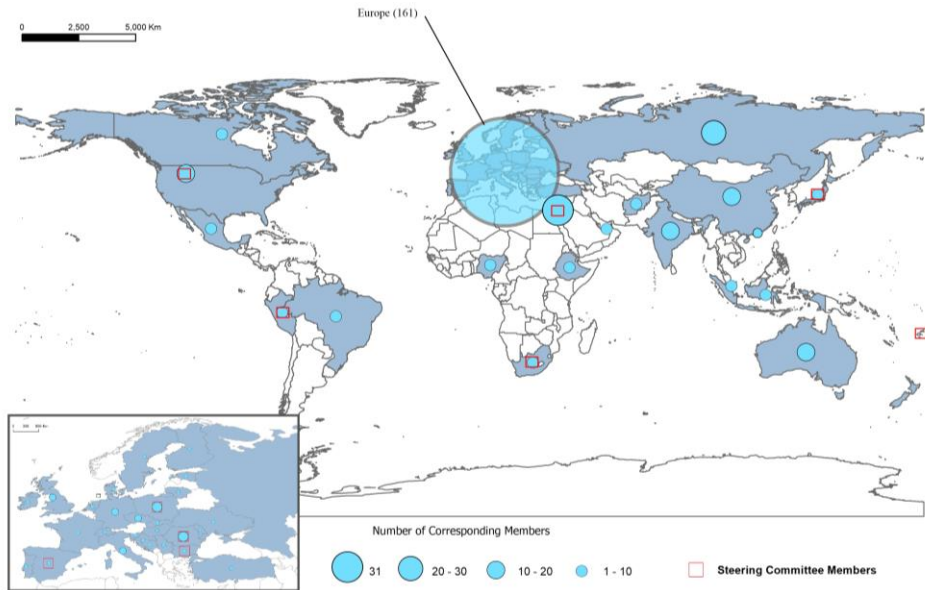


Figure 2. The spatial distribution of the Steering/Corresponding Members by country, 2022

Currently, the Commission on Local and Regional Development counts a total of 334 members from 50 countries (Fig. 1). Based on the estimation of the Members of the Steering Committee, about 50-60 members are considered active in the sense that they participate in the meetings organized by the Commission, the sessions within the events organized by the IGU, contribute with articles/chapters in the volumes and special issues of the Commission or of the IGU, etc. However, all members are

informed about all the events organized by IGU or related to it. A lower participation of countries from the Global South is still maintained, a situation that we are trying to improve in the coming years. In 2022 the Commission expanded by 16 members. Overall, most members are from Israel (31), followed by Poland (25), Romania (21), but also India and China (17 members each) (Fig. 2).

#### PARIS 2022 UGI CENTENNIAL CONGRESS - TIME FOR GEOGRAPHERS



As part of this scientific event, the IGU Commission on Local and Regional Development held 5 sessions (totalling 13 slots) proposed by some of the Steering Committee/Corresponding Members covering the following topics:

A considerable number of Steering Members participated in Paris, including the former and current Chair, Vice-Chair and Scientific Secretary (Jerzy Bański, Ines Grigorescu, Carmen Vázquez Varela, Bianca Mitrică, Michael Sofer, Boian Koulov, Ashley Gunter, Benjamin Ofori-Amoah), to which was added a satisfactory number of corresponding members (nearly 65, 20%). All of them covered 20 countries: Austria, Belgium, Brazil, Bulgaria, Canada, Czech Republic, France, Germany, Hungary, Israel, Italy, Japan, Poland, Romania, South Africa, Slovakia, Spain, UK, Ukraine, and USA.

During the congress, there were discussions on various theoretical and applied aspects related to local and regional development, cultural tourism and its role in the local development of the rural space, methods of analysing the dynamics of land use in relation to urban expansion phenomena, socio-economic and environmental vulnerability to extreme climatic phenomena, etc. with the members of several IGU commissions: *Urban Commission: Re-Thinking cities and the urban: from the global to the local*; *Geography of Tourism, Leisure, and Global Change*; *Land Use and Land Cover Change*.

### **ANNUAL MEETING OF THE IGU COMMISSION ON LOCAL AND REGIONAL DEVELOPMENT. SOCIODEMOGRAPHIC CHANGE AND ITS IMPACT ON TERRITORIAL DEVELOPMENT POLICIES**

The meeting was organized together with the Spanish Working Group of Local Development, part of the Association of Spanish Geographers (AGE) and the Department of Geography and Spatial Planning of the University of Castilla - La Mancha. The event brought together 26 academics from prestigious institutions from 8 countries: Denmark, Hungary, India, Israel, Poland, Romania, South Africa and Spain; 18 of them participated face-to-face and 8 online. The main themes of the conference were focused on:

- Population challenges and territorial development policies.
- Between theory and practice of local development. Issues, methods, and experiences.
- Cross-border cooperation and neighbourhood policies.
- Challenges of urban-rural relationships. Implications on local and regional development.
- Territorial development and 17 Millennium Development Goals (MDGs).
- Addressing territorial inequality in a post-pandemic world.

The results of the annual meeting were presented to the public through the media, respectively the online journal of the University of Castilla - La Mancha, La Circular (<https://lacircular.es/igulocalandregional.html>) and the Facebook Group of the Local and Regional Development Commission (<https://www.facebook.com/groups/3345703419029601>).



In addition to the very interesting scientific sessions, field trips were also carried out in the city of Cuenca (whose city centre is UNESCO World Heritage since 1996), Villa Romana de Noheda & Serrania de Cuenca Natural Park. During the 2 days fieldtrips, the participants were able to examine the territorial disparities driven by the tourism concentration in the Cuenca – Ciudad Encantada – Nacimiento del Río Cuervo tourist axis, which, contributes little to the maintenance of the population of the area. In this context, were held discussions with local actors related to the main challenges the municipality and local communities are facing (e.g., depopulation, aging) and local and identified solutions for the sustainable development. At the same time, the development projects on the agenda of the municipality were debated in informal discussions between the participants and the local stakeholders.

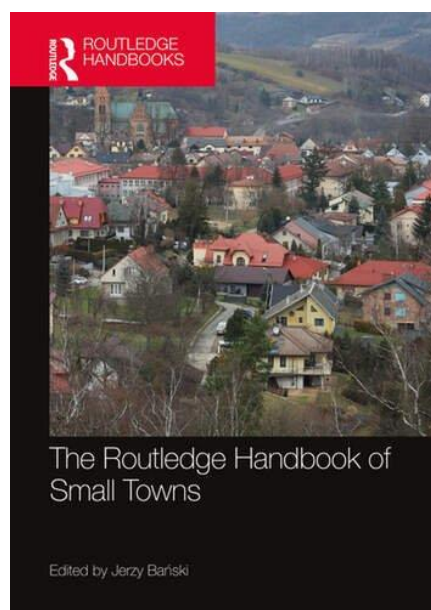
## Digital networking
